#### Key Objective of the Network

The Network brings together clinicians, managers, patient/family representatives and commissioners from across South Wales and the South West, to work together to support patients of all ages with a congenital heart condition, and their families/carers.

## Main achievements in this reporting period (Q3: Jan-Mar 2021):

### <u>Clinical</u>

- Survey conducted on current management, governance and operation of specialist peripheral clinics across the south west as part of diagnostic phase of CHD Specialist Peripheral Clinic Project.
- Initial Network Inherited Cardiac Conditions (ICC) meeting held with key stakeholders to discuss approach to ICC within CHD network.
- Dental pathway audit undertaken to assess implementation of pathway across the network
- Paediatric guidelines for Fontan's, Coarctation of the Aorta and Inherited Cardiac Conditions drafted and under review.
- New ACHD consultant appointed in Cardiff as part of the phase 2 investment into ACHD services
- Network Fetal Cardiology meeting held with discussion of complex cases for shared learning and best practice.

#### **Business**

- New and improved network performance report launched at Network Board to enable quick "status at a glance" and to agree actions to address any performance issues.
- CHD Network 2021/22 workplan drafted and approved by the Network Board
- NHS England Network Maturity Matrix exercise completed with network stakeholders to assess maturity and development of the network.
- Self-assessment visits to CHD centres in South Wales being organised. Streamlining of selfassessment process underway in collaboration with North West, North Wales & Isle of Man CHD Network.
- Recruitment for new Chair of Network Board underway, interviews planned for 27/04/21.
- Continue to support centres with their CHD recovery plans. Monthly reporting of CHD surgical and interventional waiting list information, % CHD activity restoration and escalated issues or risks to NHS England.
- Continue to lead National CHD network monthly calls, set up to allow rapid dissemination of information, discussion of clinical cases and shared learning during covid period.

### Education and research

- Paediatric cardiac nurses new monthly webinar series launched with the first two webinars held and over 60 staff registered.
- Network Psychology Day held virtually with positive feedback.



- New "Paediatric with Expertise in Cardiology" education and training virtual platform launched.
- Fetal Cardiology webinar series continues with 130 people registered including clinicians from international centres.
- Paediatric Cardiac handbook for nursing staff being finalised, to be launched in May.
- Continued with monthly bitesize education initiative "Lesion of the month" for all clinical nurse specialists and link nurses across the network.

- Network Spring newsletter drafted, ready for publication and distribution across network
- Social media campaign in collaboration with CHD support groups and network patient representatives to 'demystify the network', to promote the network and raise awareness of the support resources available
- Heart week in February 2021 promoted network on Facebook.
- Patient rep meeting held in advance of the Network Board in March

## Planned Progress for next quarter (Q1: Apr-Jun 2021)

- Appoint to Chair of the Network Board (Interviews 27/02/21)
- Draft Annual Report for 2020/21.
- Finalise self-assessment process following streamlining and standardising exercise.
- Organise and hold self-assessment visits (virtual) with level 3 centres in South Wales in collaboration with WHSSC.
- Relaunch Network Transition project.
- Plan CNS and link nurse events for next 6 months to enable shared learning and best practice.
- Draft report on peripheral clinic survey results including recommendations. Compile draft Service Level Agreement with project team members for review by NHS England & BRHC.
- Finalise paediatric guidelines & gain approval via network and governance arrangements in relevant centres.
- Complete development of inpatient performance dashboard.
- Progress plans for Echo study day and future "meet and greet" network cardiac physiologist sessions.
- Plan next network wide audit session as part of the Clinical Governance Group in June.
