Key Objective of the Network

The Network brings together clinicians, managers, patient/family representatives and commissioners from across South Wales and the South West, to work together to support patients of all ages with a congenital heart condition, and their families/carers.

Main achievements in this reporting period (Q2: Jul-Sept 2020):

Clinical

- Network wide annual Mortality and Morbidity session held virtually with over 25 attendees, very positively evaluated.
- Launched the Advanced Care Clinic for adult patients with complex congenital heart disease in September. Future evaluation of the service planned.
- Cardiac Physiologists led ECHO clinic launched in Truro, similar service being planned at BRHC.
- Survey conducted to understand current standard of discharge communications for PECs from level 1 centre. Discharge SOP in progress.
- Review of Paediatric CHD clinical service in Truro to support peripheral clinic provision by level 1 centre.
- Improved access to level 1 paediatric CHD joint cardiac conference (MDT meeting) for network clinicians to join virtually.
- Commenced work on reviewing the fetal cardiac handbook.
- Planning with level 1 centre for improving transition provision across the network.
- Supporting the development of the ACHD service in Truro following recent recruitment of ACHD consultant to the service.

Business

- Successful appointment of Network Lead Nurse (0.3WTE) to work alongside existing network lead nurse who has reduced hours following a retire and return.
- Network Annual Report 2019/20 published.
- Virtual network board held in Sept. with over 25 participants, which was positively evaluated.
- Survey on restoration of CHD activity and new ways of working across the network conducted and submitted to network board.
- Work in collaboration with PIC network to support with winter planning across the region.
- Escalation to ensure the final approval for the phase 2 business case for developing the ACHD service in Wales and meeting the CHD standards. Business case now approved.
- Continue to lead National CHD network monthly calls, set up to allow rapid dissemination of information, discussion of clinical cases and shared learning during covid-19 period.
- Monthly reporting of CHD waiting list for surgery and interventions to NHS England nationally and regionally.
- Developed virtual platform (Future platforms) site to enable hosting and sharing of network education packages for eg. Fetal cardiology
- Supported centres to use virtual technology to deliver outpatient appointments and MDTs.
- New ways of working; Network report submitted to National team and presentation delivered at Network Board by ACHD Level 1 to share learning and best practice.



- Continued work with newly established networks in South West and other developing CHD networks.
- Commenced work with NHS England and level 1 centre on understanding current peripheral clinic model provision for CHD and other specialities.
- Set up of national CHD network manager's forum to enable shared learning and collaborative working on similar challenges and projects.

Education and research

- Study day held for Paediatrician with Expertise in Cardiology across the network with a focus on single ventricle. Very well attended and positively evaluated.
- Fetal Cardiology webinar series launched- with over 90 people registered including clinicians from international centres.
- Virtual sonographer training session for district general hospitals delivered by fetal cardiology team to help improve rates of antenatal detection of CHD.
- Paediatric Cardiac Handbook developed for ward areas, to be rolled out across network.
- Continued with monthly bitesize education initiative "Lesion of the month" for all clinical nurse specialists and link nurses across the network.
- Commenced planning for annual psychology virtual event in Feb. 2021.
- Review and update of COVID-19 webpages for patients, families and staff.

Communications and Engagement

- Adult CHD CNS survey conducted on patient experience. To be rolled out to Paediatric CHD and level 2 centres.
- Patient representative's session held to discuss role and prepare for network board.
- Commenced work on virtual young person's evening and tour of the Bristol Heart Institution.
- Youth at Work support and promotion of virtual patient engagement events.

Planned Progress for next quarter (Q3: Oct-Dec 2020)

- 18th Annual ACHD study day to be held virtually in October.
- CHD Network 2021/22 priority setting workshops to be held with network board members.
- Quarterly report to and attendance at inaugural NHS England South West Women & Children's programme board in November.
- Continue to support centres with their CHD recovery plans. Capture CHD surgical and interventional waiting list information, % CHD activity restoration and escalated issues or risks on behalf of NHS England.
- Finalise plan for level 1 paediatric centre with for provision of transition clinics in peripheral areas.
- Draft 5 year strategy for the CHD network to be reviewed at Network Board in Dec. 2020 (virtual) for approval.
- Relaunch self-assessment and engagement visits (virtual) with level 3 centres in the network.
- Complete development work on performance dashboard and implement for network.
- Launch CHD Nurse Competencies across the network.
- Draft scoping document for work on peripheral clinic provision, to include current state diagnosis.
- Finalise key SOPs currently in progress (Discharge SOP and joint fetal pathway).
- Continue to work with WHSSC on adoption of CHD standards in South Wales.
- Autumn CHD network newsletter to be published.
- Launch of Youth workers "Cuppa & Catch up" online sessions for young people.
